Subcommittee Development & Team

CAHC

-Had a small, brief meeting at the September meeting and noted how CAHC falls into every area of behavioral health.

-Appreciate the visual that Holly had made, helps to push understanding of the initiatives and the connections, between behavioral health and all areas we are currently working on.

-The CAHC team was responsive to the goals in the initiative. We had a great discussion about CAHC trainings and want to make sure that the trainings meet the needs of the professional, but also be focused, and be true to what the committee wants for cultural competence moving forward. This should not just be another training that individuals take but don't absorb and so isn't meaningful and thus doesn't actually help move the initiative forward.

Telehealth

-At the September meeting, spent most of the meeting updating their Telepsych list.

- Talked with Mariela with the Systems of Care team and Iris process of referrals.
- They discussed gathering data as much as possible.
- Discussion around where to house this list.

Mental Health Directory

- Mariela shared the Tri-County Mental Health Directory, the goal is for providers not patients.
 - The directory included pages of definitions.
 - Mental Health Crisis resources has it's own section, with different topics (includes organization, phone, location, hours, cost, language, services, etc.).
 - Also splits it into mental health resources per county.
 - It was suggested an invite be sent to all the organizations and they can inform of the services they provide.
 - Have a section for Tri-County Disability and Resources specifically as well.
 - They are still working on how others can add to the list, as it's housed under the Systems of Care grant, for now it can be emailed to Mariela Munguia: mariela.munguia@carle.com.
 - Could be posted on the Partnership website or health department websites.
 - Does not want this to be specific to only Carle or OSF, etc. Needs to be a community wide list.
 - Would like one person from each sector to possibly meet with Mariela and review information and help to keep it accurate.
 - Iris has a capacity bar to know when providers are reaching their capacity, can inform others that are referring. You have the ability to designate what services are available as well.
 - Iris was mostly designed for children's agencies and not for hospital systems. There is a long contract associated with Iris, PHI is an issue for the hospitals, as it started out as family referrals.
 - They have quarterly meetings with University of Kansas and have about 64 agencies on Iris. They will be able to give them feedback and share their data dashboards.
